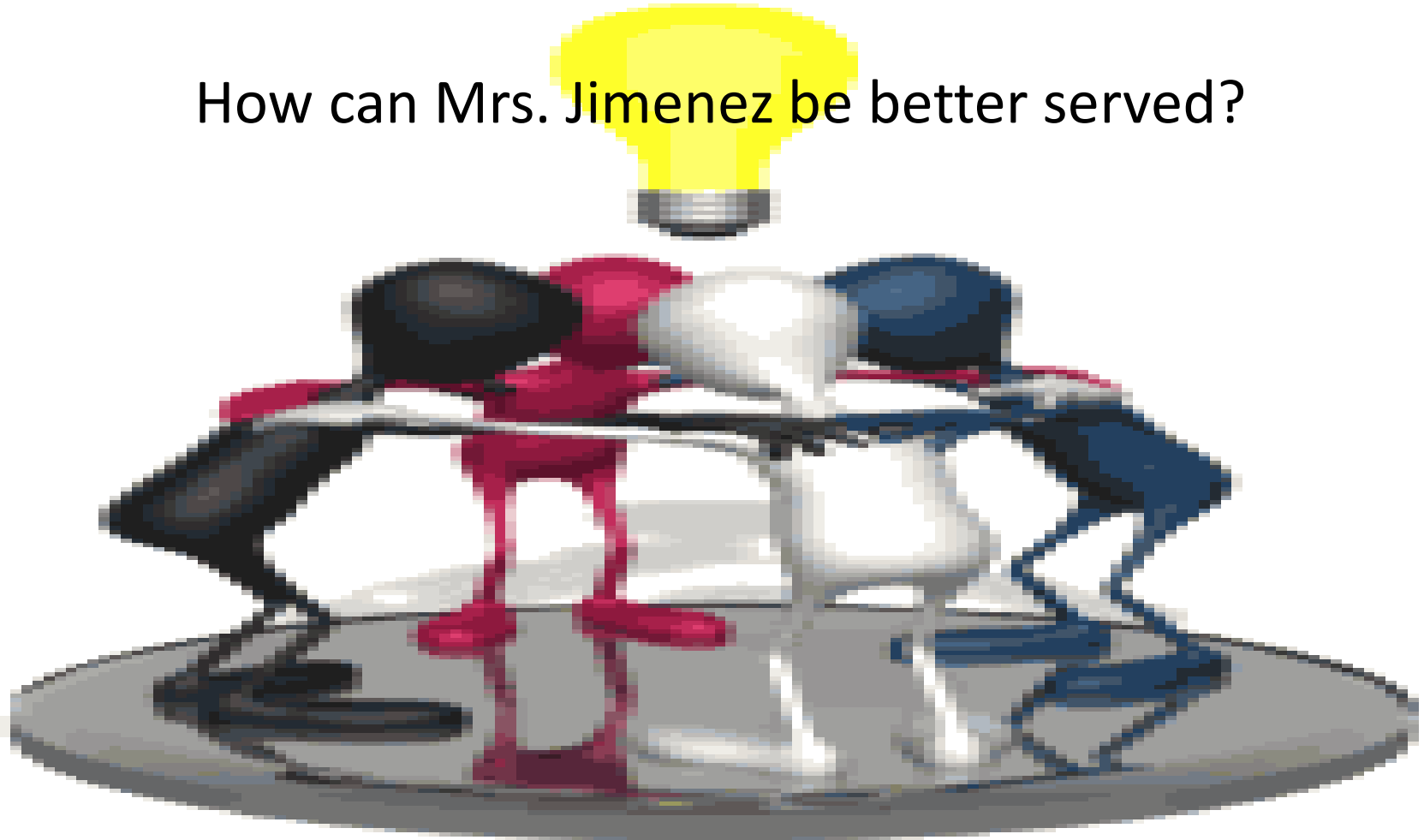

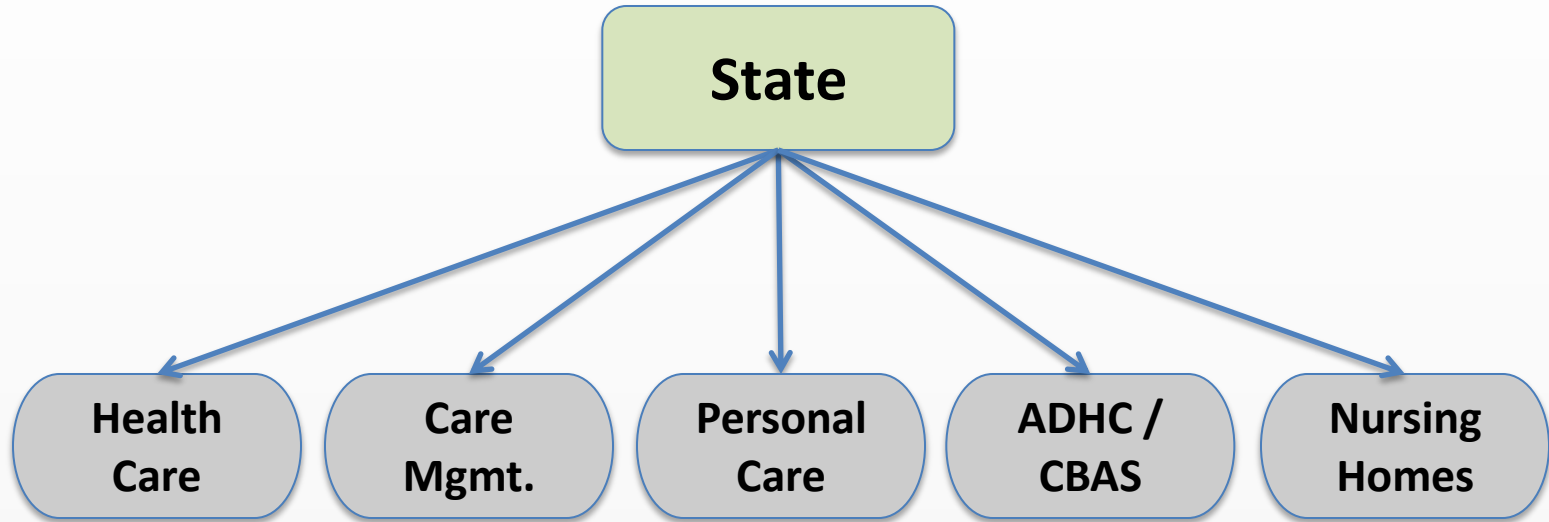

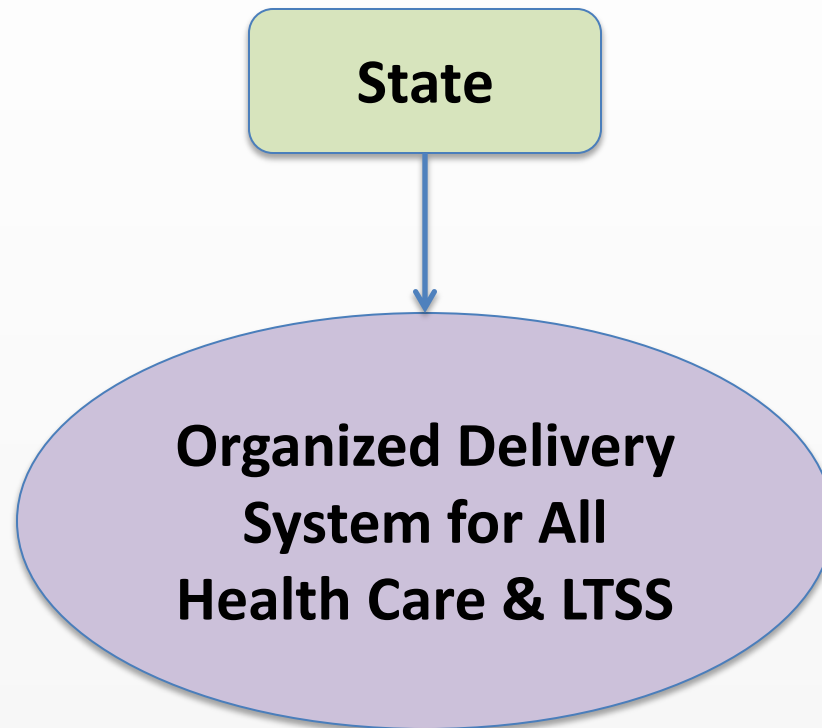

1115 Waiver Renewal: Objectives



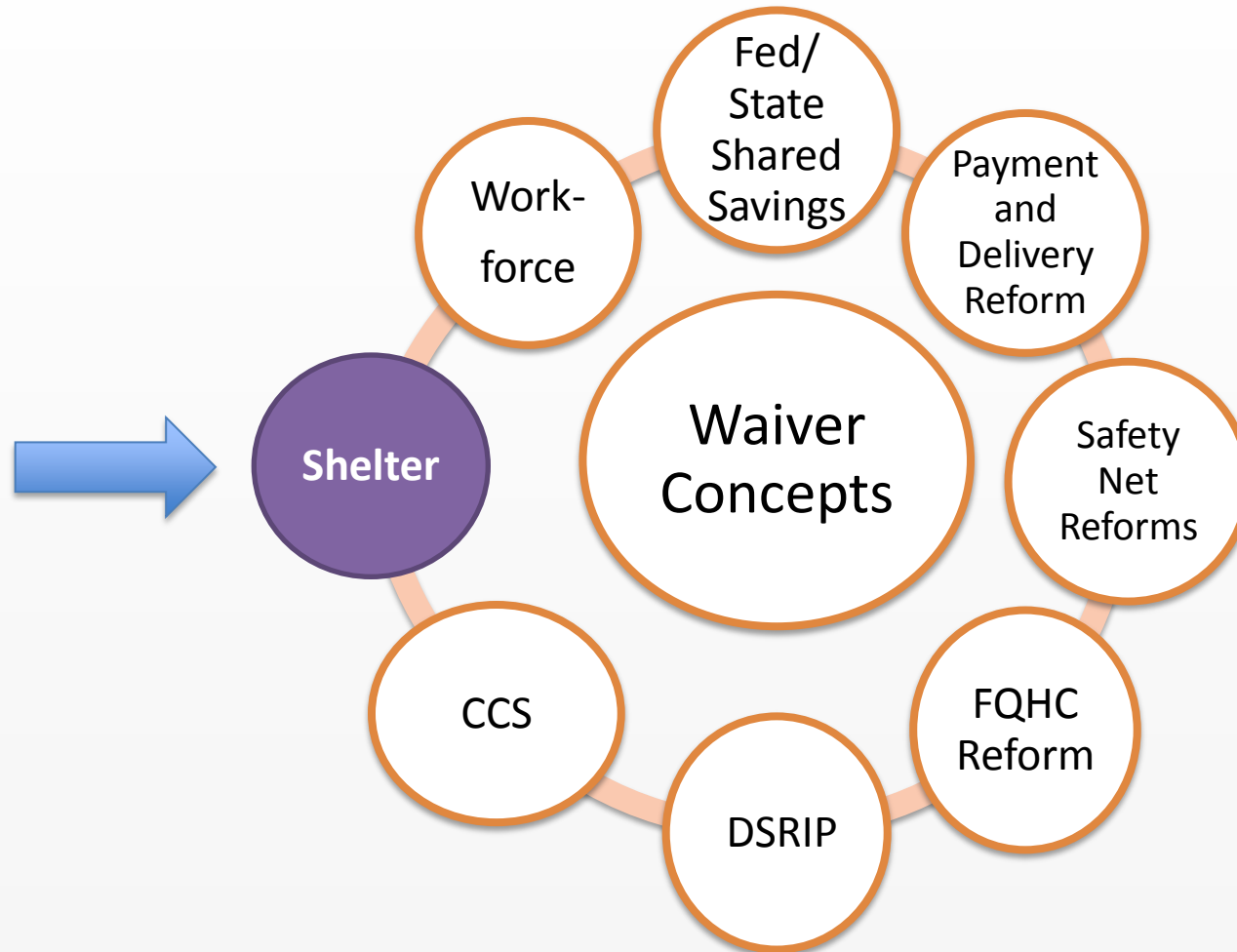
Strengthen primary care delivery and access

Avoid unnecessary institutionalization

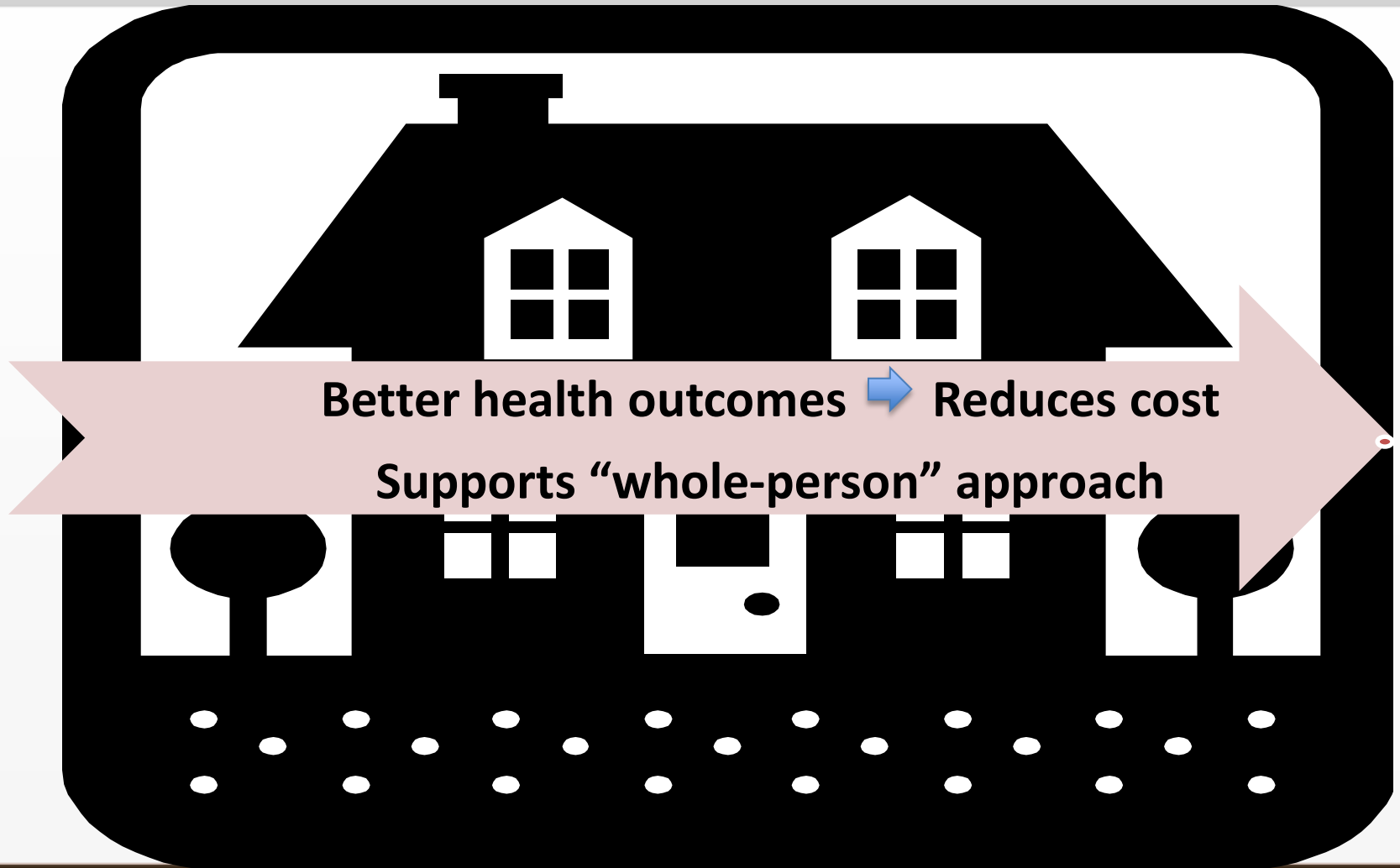
Address social determinants of health

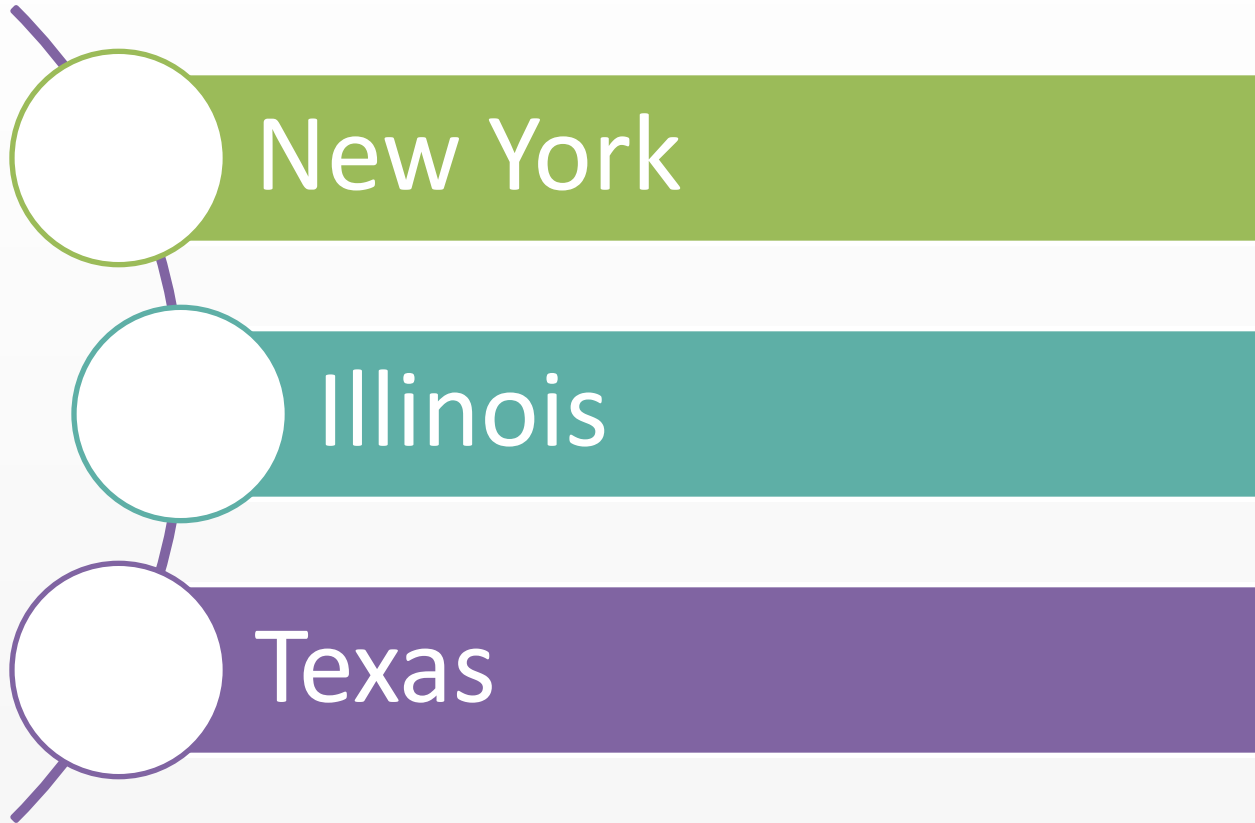

Overview: Coordinated Care Initiative

Coordinated Care Initiative (CCI):

Transform California's Medi-Cal delivery system to better serve low-income older adults and persons with disabilities

CCI Enacted through Budget Act of 2012

CCI Basics: What It Is

CCI	Description
Mandatory Medi-Cal Managed Care	Dual eligible individuals must enroll in Medi-Cal Managed Care.
LTSS Integration	LTSS added to Medi-Cal Managed Care plan benefit package
Medicare Integration (Cal MediConnect)	For dual eligible individuals, integration of Medicare and Medi-Cal benefits into one managed care plan.

CCI Basics: Who, Where, When

Who

- Dual Eligibles
- Medi-Cal only SPDs

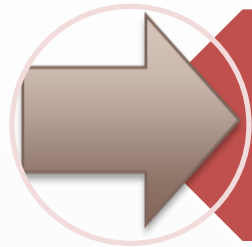
Where

- 7 counties: Los Angeles, Orange, Riverside, San Bernardino, San Diego, San Mateo, & Santa Clara

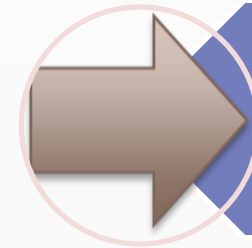
When

- Implementation ongoing in six counties. Orange scheduled for July 2015

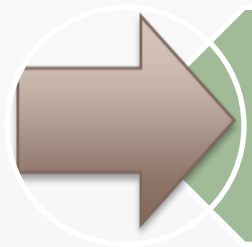

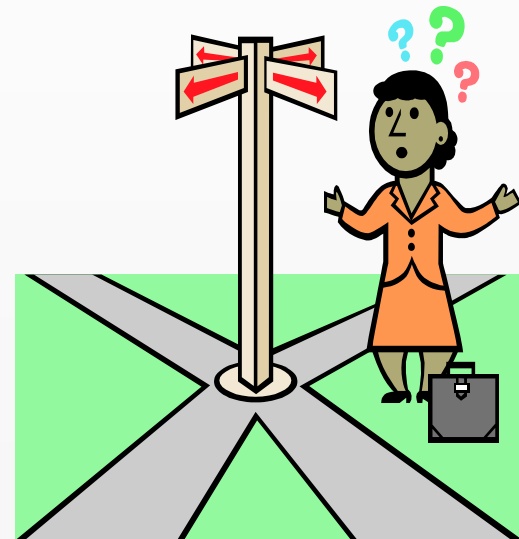
CCI: Innovative Approach

Building Partnerships with Managed Care Organizations

Develop a Business Case, Must Demonstrate

1. Economic burden if nothing is done
2. Your services can alleviate some of that burden
3. Economic value of your services $>$ expenses managed care partner will incur to pay for them
4. By you delivering the services, you create more benefit than competitors or health plan creating service themselves
